## **REQUIREMENTS**

- Accomplished passport application forms (both the regular passport application form and the application for extension of validity form). Please write legibly and fill-in the details/information requested completely, including the undertaking that is required of applicants in the form. Forms that are not accomplished completely will be returned.
- 2. The applicant may send the accomplished application form and supporting documents by mail and does not need to personally appear at the Philippine Embassy in Brasilia, unless the Consular Officer deems it necessary after due evaluation of the application.
- 3. Two (2) passport photos (3.5 x 4.5 cm, colored with white background without eyeglasses). Digital photographs will not be accepted.
- 4. Submission of the original passport that is already expired or due to expire, including a photocopy a copy of the data page (the page which contains the personal data of the passport holder), the last page and the page containing the latest immigration arrival stamp in Brazil, Colombia, Suriname or Guyana, as may be applicable.

For applicants requesting amendment of their passport to married, a copy of the Report of Marriage duly registered with the Philippine Embassy or Consulate that exercises jurisdiction over the applicant's place of marriage should be submitted.
